Release Notes

Update V10.9.30 – February 3, 2010

1. New 2010 DHL Rates. (the rates are effective April 1st). In order to apply the new rates you will have to go to Setup -> General Setup Options -> Carrier Setup -> DHL -> DASC Rate Type. Select what tier level rates you have and click 'Update Now'.
2. DHL to Canada. The EXP service to Canada will be changed to INT.
3. Fix [Mailbox] Changed MBXNotice.rpt to include the store phone number
4. Fix [ZReport] Fixed formatting on the Datewise Z report to show % instead of \$ for the Margin.
5. Fix [Reports] Fixed random crystal report errors
6. Fix [Inventory] Error message kept prompting some people to reinstall ReportViewer every time they print labels.
7. Customer Lookup: The Reference number field was changed to search by account number
8. MSRP field added to inventory. When printing Inventory labels you can now have a MSRP price showing below your regular retail Price

1. Fix [UPS] - in some cases the weight of a package is rounded wrongly when transferring to Worldship

v. 10.8.9 – January 2, 2009

1. New: [Shipping] FedEx Web Services XML Integration added. Allows for international shipping as well as address verification.
2. Fix: [Purchase Orders] Purchase Orders: When receiving purchase orders the inventory is now updated correctly
3. Fix: [Setup] Store Email address field added to the Registration tab at the Setup screen.
4. Fix: [Contacts] Shiprite allows now email address that end with 4 characters after the dot.
5. Fix: [Endicia] "Print Free Test Label" check box is checked all the time after shipping international at the Preview Label screen.

v.10.7.79 – July 14th 2008

1. New: [Main Form] 'Support Request Center' sub-menu was added to the 'Help' main screen menu, which will open "Online Support Center" web page for submitting support requests and tracking requests status.
2. New: [Ship Master] 'Show Package Details' right-click pop-up form will have 'Ship Date' displayed for each service.
3. Fix: [POS] If a non-taxable item is 'OnHold' then after taking it off hold and adding a taxable item to the sale results in the Sales Tax not being calculated.
4. Fix: [Ship Master] When making a DHL delivery date request from the shipping screen, if it's DAS it will say that there is no commitment and the option to ship with that service goes away.
5. Fix: [Ship Master] Show new DHL delivery date request warning for DAS shipments.
6. Fix: [Ship Master] 'Saturday Delivery' for Next Day services is not available if Friday happened to be a Holiday.

7. Fix: [Ship Master] 'Fuel Surcharge' should be calculated based on Shipping Cost plus Additional Costs (not Charges) and marked up by Fuel Surcharge charge value setting.
8. Fix: [Scale] Scale error#13(Type Mismatch) with Serial Port scale if the weight on the scale is less than a pound.
9. Fix: [ThingsToDo] Prevent users from double-clicking <Print> button to avoid Crystal Report errors.
10. Fix: [Price Chart] 'USPS Domestic' Zone1 and Zone2 rates are the same and should be listed only in Zone2 column of the report to fit the other Zone rates in the report page.
11. Fix: [EOD] 'Ship Date' advance change will be visible for all the ShipRite computers after the change is made.

v.10.7.73 – July 1, 2008

1. Fix: [Ship Master] DHL (DAS) XML reply format of the successful shipment has changed, which is not recognized by ShipRite. The shipment won't be recorded in ShipRite but it will be billed by DHL.
2. New: [Ship Master] New "List All ShipTo Addr(s) for Shipper" right-click pop-up menu option (F8 hot-key) was added to the ShipTo address box. This option will list all the ShipTo addresses for the selected ShipFrom address, by selecting a ShipTo address from the list - the selected address will be automatically filled in the ShipTo address box.
3. New: [Setup] DHL Rate Type captions for 'Basic Retail Program', 'Standard Retail Program', and 'Preferred Provider Program' were changed to 'AMPC Basic Retail', 'AMPC Standard Retail', and 'AMPC Preferred Provider Program' accordingly. Changed only the name the actual rates are the same.
4. New: [Ship Master] FedEx Dimensional Weight Rounding rule (Service Guide p.122): "Dimensions of one-half inch or greater are rounded up to the next whole number; dimensions less than one-half inch are rounded down."
5. New: [POS] 'Recover Previous Package' procedure was optimized to pull top 30 Invoice#s packages to recover. The recovered packages could be put OnHold and/or Deleted to avoid looking for them again.
6. New: [POS] Ability to Delete an Invoice# (when prompted) was added from <Invoice Lookup> if there are no transaction details were found due to an error during completing the transaction.
7. New: [MailBox Manager] After renting a mailbox is done – if no reports were asked to be generated ShipRite won't close 'MailBox Manager' form automatically to avoid Crystal Report errors.
8. Fix: [MailBox Manager] If no reports are asked to be generated then return automatically to the caller form.
9. Fix: [POS] When RBS Lynk is disabled, ShipRite carries the Refund amount from previous transaction to the New Sale Payment screen total.
10. Fix: [Reports] ShipRite should not add one Statement charge twice in any circumstances to avoid wrong Statement Balance.
11. Fix: [Ship Master] A carrier service 'Saturday Delivery' validation check should be based on the Ship Date set by the user at the EOD screen for this carrier.
12. Fix: [Price Chart] 'DHL Domestic' print Price Chart option was not working.
13. Fix: [Stamps.com] If Stamps.com is disabled in the ShipRite Setup Options then it should not be available as the option in the Ship Master screen.
14. Fix: [Ship Master] USPS should allow COD up to \$1,000.00 with 3rd Party Insurance turned off.
15. Fix: [Ship Master] USPS COD rates were updated to reflect the May 12, 2008 changes.
16. Fix: [Ship Master] USPS Express Mail has first \$100 insurance Free to consider while processing USPS Express Mail COD less than \$100.
17. Fix: [Ship Master] USPS COD in Endicia has priority over Declared Value - COD amount will overwrite Insurance amount.
18. Fix: [Reports] Distribute Packages 'Signature Sheet' report's Printer ScaleMode property should be set to Inches to be properly formatted on a page.
19. Fix: [Reports] MailBox Notice reports: 'Sale Tax' values has to be rounded to 3 decimal point to avoid overflow in Crystal Reports.
20. Fix: [Printers] Networked USB Receipt printer won't go through Port Check procedure - we should assume that the printer is available to make it work properly.
21. Fix: [Reports] POS form calls to ShipMain Crystal Report control replaced with a local one to avoid Err#20507(Invalid report file name).
22. Fix: [Reports] MailBox Manager form calls to ShipMain Crystal Report control replaced with a local one to avoid Err#20507(Invalid report file name).
23. Fix: [Mail Master] Mail Master should be able to apply Postal Insurance to First Class Mail (FCM) even if a FCM SKU supplied instead of the actual service name.
24. Fix: [Ship Master] Only 'Other' packaging type should be available to the Ground services.
25. Fix: [Mail Master] Updated images for "need info?" links.

26. Fix: [Reports] ThingsToDo form calls to ShipMain Crystal Report control replaced with a local one to avoid Err#20507(Invalid report file name).
27. Fix: [ThingsToDo] If Mailbox department set as taxable then '... Notice' reports should show the mailbox rates with tax included.
28. Fix: [Mail Master] USPS Flat Rate packaging in MailMaster (and ShipMaster without Endicia or Stamps.com) should use retail rate - no electronic discounts are applicable.

v.10.7.58 – May 29th 2008

1. New: [EOD] "Ship Date" date-picker was added to the EOD screen for each of the Carriers to enable 'Date Advance' feature in ShipRite.
2. New: [EOD] 'Manifest Type' drop-down box was made available for all carriers to set "Ship Date" by Ground and/or Air selected carrier services.
3. New: [EOD] 'Manifest Type' drop-down box options will allow a user to print Manifest report filtered by Ground, or Air, or Both for DHL and UPS carriers.
4. New: [EOD] 'Manifest Type' drop-down box options will allow a user to upload shipments filtered by Ground, or Air, or Both for DHL, FedEx, and UPS carriers.
5. New: [Printers] ShipRite will be able to work with USB Thermal printers, by mapping your USB Printer to LPT port. Note: you would have to re-select the existing Thermal Printer Name in Setup -> Local Features tab-page for ShipRite to recognize it as USB. After mapping is done successfully you should select just the LPT port number for all your thermal label printer settings.
6. New: [Setup] For "PRINTER - DHL Label" printer setting after clicking <Update Now> button an additional question "Is it Thermal Label Printer?" will be asked to make sure the right label format will be applied.
7. New: [Credit Card] "CVV2" field is set to accept a 4 digit number.
8. New: [Credit Card] Credit Card Type auto-identification has been introduced in the Credit Card screen.
9. New: [Z-Report] Credit Card Type was added to the Z-Report Credit Cards section with subtotal for each type.
10. New: [Z-Report] Sub-totals for "American Express" and "Other Charge Cards" credit types were added to the Z-Report "Collection Summary" for "[+]Credit Card" entry.
11. New: [Quick Books] 'Show Entries upto Days' text-box was added to limit QB General Journal entries view to speed up the process.
12. New: [Services] USPS First Class Mail International service tables (USPS-INTL-FCMI_Letter and USPS-INTL-FCMI_Flats) were added for rates viewing to the Services screen.
13. New: [Refund Tech] Email capability was added to EOD Refund Tech uploads for users with Refund Tech FTP access problems.
14. New: [User Security] "Discounts" user option (if disabled) should deny user from accessing: POS 'Item Discount' and 'Change Price' button options.
15. Fix: [Reports] if Mailbox department set as taxable then 'Expiration Notice' report should show the mailbox rates with tax included.
16. Fix: [Reports] if Mailbox department set as taxable then 'Cancellation Notice' report should show the mailbox rates with tax included.
17. Fix: [Endicia] DAZZle won't accept "Serbia & Montenegro" as a valid country name - only as "SERBIA, REPUBLIC OF"
18. Fix: [Endicia] Endicia InstaPostage is a full retail pricing. The discounts only apply to integrated labels with tracking.
19. Fix: [POS] 'Quick Refund' check should stay enabled (if was enabled) only for POS <Receipt/NoReceipt> button options.
20. Fix: [POS] 'Taxable Departments' collection was created to avoid database errors return wrong value as not taxable (default) for actually taxable departments.
21. Fix: [MailBox Manager] 'Distribute Packages' email notification problem with Thunderbird email clients.
22. Fix: [Address Entry] Once you save a contact, you cannot go back and change the country for that contact.

v.10.7.51 – May 9, 12, 2008

1. New: [USPS] USPS May 12, 2008 Changes: Express Mail will use Zones 1-8 to determine delivery destination.
2. New: [USPS] USPS May 12, 2008 Changes: Express and Priority Mail will use cheaper Commercial rates if used with Stamps.com or Endicia.

3. New: [USPS] USPS May 12, 2008 Changes: New First-Class International rates were added for Letters, Flats(Large Envelopes), and Packages.
4. New: [USPS] USPS May 12, 2008 Changes: Flat Rate Packaging with Express and Priority Mail will use cheaper Commercial rates if used with Stamps.com or Endicia.
5. New: [USPS] USPS May 12, 2008 Changes: Flat Rate packaging costs will be updated automatically between Retail and Commercial rate types.
6. New: [USPS] USPS May 12, 2008 Changes: Online Incentives/Discounts was implemented for USPS International services.
7. New: [USPS] USPS May 12, 2008 Changes: New Insurance rates for Domestic and International shipments are implemented.
8. New: [Master Shipping Table] USPS May 12, 2008 Changes: New "Postal Insurance" tab-page was added to the Master Shipping Table screen to manage Insurance Sell Prices from ShipRite.
9. New: [USPS] USPS May 12, 2008 Changes: Postal Insurance is not available with First Class Mail International.
10. New: [Mail Master] USPS May 12, 2008 Changes: New Insurance rates for Domestic and International shipments are integrated into Mail Master.
11. New: [Mail Master] Postal Insurance restrictions for Priority Mail International based on the ship-to-country were implemented into Mail Master.
12. New: [Mail Master] Accessorial Charges grid-table was removed from Mail Master 'Setup US Mail' screen – all the programming logic for First Class Mail is being carefully prepared to add First Class Mail as a separate service (as all other USPS services) to allow it to be used in Ship Master screen in the future releases.
13. New: [Mail Master] For now, USPS First Class Mail for domestic shipments will use Certified Mail and Return Receipt rates from Priority Mail (Accessorial Revenue) until First Class Mail will be added as a stand-alone service into Ship Master.
14. New: [Mail Master] For now, USPS First Class Mail for domestic shipments will use Delivery and Signature Confirmation rates from Parcel Post (Accessorial Revenue) settings until First Class Mail will be added as a stand-alone service into Ship Master.
15. New: [USPS] Flats/Envelope rates for Bound Printed Matter were added if used with Letter packaging type.
16. New: [USPS] "Store address" check box options was added to USPS Preview Label screen for return address to allow a user select between customer only and customer name plus shipping store address combination.
17. New: [Stamps.com] ShipRite will open a different looking label printing Stamps.com screen in order to avoid crashes with the previous one. The fix for ShipRite crashing while shipping with Stamps.com is still in the air... For now, the different shipping Stamps.com screen is our current work-around until the problem resolved.
18. New: [DSI] "Member of DSI Premiere Program" check box was added to the DSI Insurance Setup screen. DSI will file claims with the carriers on the stores behalf starting from dollar zero (\$0.00). See details at DSI website.
19. New: [DSI] For the DSI Premiere Program members, ShipRite will transmit to DSI server the whole amount of the declared value starting from \$0.01, as DSI will charge premium for them.
20. New: [Fingerprint Login] New ability of Fingerprint check for user login into ShipRite has been implemented.
21. New: [Fingerprint Login] Time Clock - User Fingerprint Punch In/Out has been implemented in addition to the regular User Key Pad login.
22. New: [POS] New 'Quick Refund' (accessed from POS Sale menu) was implemented to make it easier to make a refund by clicking on the Receipt View items. Note: 'Quick Refund' is available only with "Simple Cash Register" POS style and quantity of the item to be refunded is taken directly from the Receipt View.
23. New: [Payment] Added "Exact Cash" dollar-like looking image to automatically enter exact amount to be paid.
24. New: [Reports] New "Post Office - Cancelled MBoxes" report was added to the MailBox Manager to list all the cancelled mailboxes even the ones with deleted Consignees.
25. New: [Reports] Sales Clerk field was added into "Order by Carrier" report for tracking sale purposes.
26. New: [DHL] From now on DHL XML will be enabled by default; there will be no more of DHL EDI setup.
27. New: [Distributed Packages] Process Status list view was added for the user visual.
28. New: [Distributed Packages] One email message will be sent to a recipient containing multiple packages.
29. New: [Shipment History] PackageID and Tracking# fields were made as text boxes (in Shipment History package details screen) to allow a user to copy the contents of these fields.
30. New: [Ship Master] Default Ship From contact info will be pulled from the registration key.
31. New: [User Security] "All Other Tables" user option (if disabled) will deny user from accessing: Inventory, QuickBooks Management Module, and other tables.

32. Fix: [Customs Form] User input weight 'Type Mismatch' error fix.
33. Fix: [Customs Form] Scale weight validation issue has been resolved.
34. Fix: [Endicia] USPS Customs Number should be recorded into Shipment History for the International shipments.
35. Fix: [Reports] Address Book, Contacts report should be filtered according the user selected parameters.
36. Fix: [Reports] if Mailbox department set as taxable then 'Renewal Notice' report should show the mailbox rates with tax included.
37. Fix: [WorldShip] WorldShip Commercial Invoice multiplies declared value for unit quantity by the number of units resulting in a wrong total invoice value.
38. Fix: [UPS] 'Letter', 'Pak', and 'Tube' packaging types are not available for UPS Ground service.
39. Fix: [Ship Master] "Cards, Letters, Labels" right-click option menu to Microsoft Merge feature is fixed.
40. Fix: [Ship Master] When shipping with "Ship Multi" from POS screen, the second package draws an address from someplace unknown after clicking on the "Same as last" ShipTo link option.
41. Fix: [Preview Label] Custom label signs won't print if a thermal printer name (not the actual LPT port) is set in the setup.
42. Fix: [Printer] If DHL Label Printer is set to other than "UPS Thermal Printer" or "LPT" port ShipRite will try to print a laser printer format label to the printer.
43. Fix: [Spee-Dee] Spee-Dee Track Shipment out-dated link is changed to the currently working one.
44. Fix: [Mailbox Manager] Mailbox "Deposit Key" and "Other Deposit" check-box settings' behavior.
45. Fix: [POS] Mailbox customer receipt items should be deleted without zeroing the total receipt amount.
46. Fix: [Letter Merger] In Letter Master, when merging with MS Word is not pulling the store address and the store owners information.

1. New: [Endicia] ShipRite has integrated Endicia, which contains of two Endicia programs: DAZZle Designer for printing live USPS label (including International) from ShipMaster and InstaPostage for printing USPS postage stamps from MailMaster. 2. Fix: [Stamps.com] Stamps.com version 7.0 fix that prevents ShipRite from crashing after printing two or more labels with Stamps.com.
3. New: [USPS] Certified Mail and Return Receipt charge/cost were added to the USPS Accessorial Revenue.
4. New: [Packaging] New "Packaging" tab-page was added to the Master Shipping Table screen to manage carrier packaging types from ShipRite. Packaging tab-page located at: Actions -> Table Management -> Shipping Master Table main form menu. Select carrier name in "Carrier Selection" drop-down list and the Packaging tab should show up. Don't click on any of the carrier services; it will make the Packaging tab disappear.
5. New: [Packaging] Packaging base cost and sell price settings were added for Flat Rate packaging in ShipMaster.
6. New: [Packaging] Packaging base cost and sell price settings were added for Flat Rate packaging in MailMaster.
7. New: [MailMaster] Flat Rate check box was replaced with Flat Rate combo-box to accommodate new Flat Rate packaging types.
8. New: [ShipMaster] New "Packaging" items to match UPS WorldShip ones were added in Ship Master.
9. New: [Shi Master] New Customs Form for International shipments was created to accommodate up to 5 items to satisfy custom regulations.
10. New: [WorldShip] "UPS Box 10kg" and "UPS Box 25kg" packaging items are added to the ShipRite with WorldShip integration for International shipments.
11. New: [WorldShip] ShipRite will be able to transfer up to 5 declared items from new Customs Form to WorldShip goods invoice section.
12. New: [WorldShip] WorldShip "Reason to Export" invoice entry will be adjustable according the new "Type Of Contents" selections on the new ShipRite Customs Form.
13. New: [Reports] Commercial Invoice report was updated to accommodate up to 5 items in the declaration.
14. New: [MailBox Manager] Mailboxes that passed the Mailbox End Date used to have 'x' in front of their names, now 'x' replaced with 'Ex(Date)' format where 'Date' is the Mailbox End Date.
15. Fix: [Reports] Statement report Previous Balance should be the first start value to add the rest of the values to (sorted by Date/Time).
16. Fix: [Preview Label] ShipTo address on the Preview Label screen was adjusted to fit 4-line addresses.
17. Fix: [MailBox Manager] Delete person info from Address Book fails if this person used to rent a MailBox.

18. Fix: [User Security] "View Shipping Costs" user option (if disabled) should deny user from accessing: Package Details, Shipment History, and Manifest.
19. Fix: [User Security] "All Other Tables" user option (if disabled) should deny user from accessing: Inventory and other tables.
20. Fix: [User Security] "User Accounts" user option (if disabled) should deny user from accessing: Customer Accounts (A/R) form.
21. Fix: [ShipMaster] "AH" - additional handling visual indicator should be displayed in the Scale panel when it's applied manually from the button panel.
22. Fix: [ShipMaster] 'Set Default Ship-From' is taken off the right-click pop-up menu, since the default address is always the shipper address from the registration page.
23. Fix: [QuickBooks] Voided sales should not be exported to QuickBooks Management module.

1. New: [Ship Master] DHL "Excess Limits Fee" of \$50 will be applied for all DHL packages with DIM or Actual weight greater than 150 lbs.
2. New: [Ship Master] DHL Ground Additional Handling will double if one of dimensions is over 60" and another is over 30" at the same time.
3. New: [Ship Master] DHL Ground Additional Handling won't apply if DHL "Excess Limits Fee" of \$50 is applied.
4. Fix: [Ship Master] USPS Parcel Post Machinable service won't be available if the package length is greater than 34 inches or width/height is greater than 17 inches, as well as length is less than 6 inches or height less than 1 inch or width less than 3 inches.
5. Fix: [POS] "Payment to the User Account" printed receipt should show "OrderID" and "ApprovalID" of the credit card transaction.
